10	A BILL to amend and reenact §17C-7-3 of the Code of West Virginia,
11	1931, as amended; and to amend and reenact §17C-11-5 of said
12	code, all relating to operating a bicycle or overtaking a
13	bicycle on a roadway.
14	Be it enacted by the Legislature of West Virginia:
15	That §17C-7-3 of the Code of West Virginia, 1931, as amended,
16	be amended and reenacted; and that §17C-11-5 of said code be
17	amended and reenacted, all to read as follows:
1.8	ARTICLE 7. DRIVING ON RIGHT SIDE OF ROADWAY, OVERTAKING AND
19	PASSING, ETC.
20	§17C-7-3. Overtaking and passing vehicle proceeding in same
21	direction Passing on the left generally; penalty.
22	(a) The following rules shall govern the overtaking and
23	passing of vehicles proceeding in the same direction, subject to

- 1 these limitations, exceptions, and special rules hereinafter 2 stated.
- 3 (1) The driver of a vehicle overtaking another vehicle
- 4 proceeding in the same direction shall give an audible signal and
- 5 pass to the left thereof at a safe distance and shall not again
- 6 drive to the right side of the roadway until safely clear of the
- 7 overtaken vehicle. The driver of a vehicle overtaking a bicycle
- 8 traveling in the same direction shall pass to the left thereof at
- 9 a distance of not less than four feet at a careful and prudent
- 10 reduced speed and shall not again drive to the right side of the
- 11 roadway until safely clear of the overtaken bicycle.
- 12 (2) Except when overtaking and passing on the right is
- 13 permitted, the driver of an overtaken vehicle shall give way to the
- 14 right in favor of the overtaking vehicle on audible signal and
- 15 shall not increase the speed of his or her vehicle until completely
- 16 passed by the overtaking vehicle.
- 17 (b) Any person violating the provisions of this section is
- 18 quilty of a misdemeanor and, upon conviction thereof, shall be
- 19 fined not more than \$100; upon a second conviction within one year
- 20 thereafter, shall be fined not more than \$200; and upon a third or
- 21 subsequent conviction, shall be fined not more than \$500.
- 22 ARTICLE 11. OPERATION OF BICYCLES AND PLAY VEHICLES.
- 23 §17C-11-5. Riding on roadways and bicycle paths.
- 24 (a) Every person operating a bicycle upon a roadway shall ride

- 1 as near to the right side of the roadway as practicable, exercising
- 2 due care when passing a standing vehicle or one proceeding in the
- 3 same direction.
- 4 (b) Persons riding bicycles upon a roadway shall not ride more
- 5 than two abreast except on paths or parts of roadways set aside for
- 6 the exclusive use of bicycles.
- 7 (c) Whenever a usable path for bicycles has been provided
- 8 adjacent to a roadway, bicycle riders shall use such path and shall
- 9 not use the roadway.

NOTE: The purpose of this bill is to improve the safety of those persons operating bicycles on a roadway.
